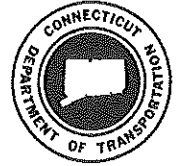

Pursuant to Connecticut General Statutes Sections Section 4-181a(b), the Department of Transportation, Bureau of Engineering and Construction, petitioner, requests a reconsideration of the final decision issued in Docket Number 1206-96-RR on May 20, 2013, based on changed conditions.

In accordance with Connecticut General Statutes Section 4-177a and Regulations of Connecticut State Agencies Section 13b-17-141a:

**TO PETITION FOR PARTY STATUS:**

1. A written petition must be submitted to the agency;
2. A copy of such petition must be mailed to all known parties (usually the Petitioner); and
3. The petition must state facts that demonstrate that the petitioner's legal rights, duties, or privileges will be specifically affected by the agency's decision.

**TO PETITION FOR INTERVENOR STATUS:**

1. A written petition must be submitted to the agency;
2. A copy of such petition must be mailed to all known parties (usually the Petitioner) and
3. The petition must state facts that demonstrate that the Petitioner's participation is in the interest of justice and will not impair the orderly conduct of the proceeding.

All petitions and certifications of party notification must be received by this agency five (5) days prior to the date of the public hearing; otherwise such requested status will be denied.

An original and FOUR (4) copies of all prepared documents and exhibits intended to be introduced as evidence in this matter by the Petitioner and any other party or intervenor must be filed with the Department not less than FIVE (5) days prior to the date of the public hearing. All filings must be mailed or delivered to:


