## I. INTRODUCTION

Graebel Connecticut Movers, Inc., is the holder of Certificate Number HG-1590, last issued by the Department of Transportation (hereinafter "Department") on September 4, 1984. Graebel Connecticut Movers, Inc. is authorized, pursuant to said certificate, to operate motor vehicles in the transportation of household goods for hire as a household goods carrier, over irregular routes between all points in Connecticut upon calls received from a headquarters in North Haven.

## II. CHANGE OF OWNERSHIP

By joint application filed, pursuant to Section 13b-406 of the Connecticut General Statutes, on January 28, 2015, and assigned Docket Number 1501-T-11-HG, the applicants, Graebel Movers, Inc. and Graebel Vanlines Holdings, LLC, seek Department approval of the change of control of the holder of Certificate No. HG-1590 by stock transfer.

## III. FINDINGS OF FACT

1. Graebel Connecticut Movers, Inc., a duly formed Connecticut corporation (hereinafter "holder"), holds Certificate HG-1590, and is thereby authorized to operate motor vehicles in the transportation of household goods for hire as a household goods carrier over irregular routes between all points in Connecticut upon calls received from a headquarters in North Haven.
2. Graebel Movers, Inc. (hereinafter "transferor") is the owner and holder of all outstanding capital stock of holder.
3. The transferor and Graebel Vanlines Holdings, LLC (hereinafter "transferee") entered into a Stock Purchase Agreement dated as of October 3, 2014 and filed said Agreement with the Department.
4. The Connecticut State Police Criminal History Conviction Report shows no criminal record for the owners of the transferee.
5. The transferor has been in operation and in good standing for six (6) months prior to the transfer as evidenced by the submission of six (6) months of bills of lading.
6. The transferee is financially viable to operate a household moving company.

#### IV. CONCLUSION AND ORDER

Therefore, based upon the facts stated above, and pursuant to Section 13b-400, the Department hereby approves the transfer of ownership by stock transfer. Graebel Vanlines Holdings, LLC is hereby authorized to acquire, by stock transfer, the holder of household goods Certificate HG-1590, Graebel Connecticut Movers, Inc.

#### CERTIFICATE HG-1590

#### To Operate Motor Vehicles for Transportation of Property for Hire a Motor Common Carrier

Graebel/Connecticut Movers, Inc. of North Haven, Connecticut is hereby permitted and authorized, subject to such regulation and conditions as the Department may prescribe to transport for hire as a motor common carrier over irregular routes as follows:

Within Connecticut between all points.


Certificate holder must accept and transport property herein authorized and in accordance with tariff on file, for all persons who desire the service to the extent of the certificate holder's facilities at uniform rates for all similar service.

There shall be carried in each vehicle operated under this certificate a uniform cab card with a current identification stamp issued by this Department affixed in the square for Connecticut.

This certificate is not transferable without the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws and with such rules and regulations as the Department may prescribe.
