The records of the Department of Transportation ("Department") indicate you are the holder of Permit No. 2701, and are in violation of Connecticut General Statutes Section 13b-103, as amended, by violating the terms of your permit which requires the permit holder to comply with all pertinent motor vehicle laws and other statutes, and/or rules, regulations and orders of the Department.

More specifically:

- 1) On June 11, 2015 it came to the Department of Transportation's attention that the name State Limousine Service, Inc. is being used by two different companies owned by two (2) different owners, with two different permit authorities in the town of Stamford. A certified letter was mailed to Mr. Mansoori, owner of Permit No. 2701, directing him to change the name of his business for this reason. The letter came back "return to sender". A second letter was sent to the P.O. Box listed at his second address and that the letter was unclaimed. A record check that showed the company has no vehicles currently registered. It appears this company is no longer in business. This is a direct violation of the RCSA Section 16-325-1, which provides that the permit holder must have a headquarters where the permit holder or his employee is in attendance.
- 2) Further research found State Limousine Service, Inc. does not have a Federal Motor Carrier Safety Authority (FMCSA) permit. They were using the FMCSA authority belonging to the other company with the same name (Permit No. 3255). This is a direct violation of Connecticut General Statute Section 102(b) which provides that a permit holder must register its authorization from the Federal Highway Administration with the Connecticut Department of Transportation for interstate operation.
- 3) Department records show that State Limousine Service, Inc. does not have the required insurance. This is a driect violation of Connecticut General Statute Sections 14-29 which requires operators of motor vehicles in livery service to furnish insurance.

Therefore, pursuant to Connecticut General Statutes Section 13b-103, as amended, you are hereby directed to appear at the Newington office of the Department of Transportation, 2800 Berlin Turnpike, Newington, Connecticut, Conference Room A on Thursday, September 10, 2015 at 10:00 a.m. for a citation hearing to show cause why this permit should not be revoked or suspended or a civil penalty imposed for failure to comply with the applicable provisions of the Connecticut General Statutes and/or the Regulations of Connecticut State Agencies as stated above.
