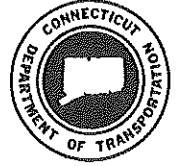

I. INTRODUCTION

A. Applicant's Proposal

By application filed on April 12, 2016, pursuant to Section 13b-389 of the Connecticut General Statutes, and assigned Docket No. 1604-N-40-HHG, Time 2 Go, LLC dba Time 2 Go Moving (hereinafter "applicant"), with a mailing address of 54 Hazard Avenue, Unit 70, Enfield, Connecticut 06082 seeks authorization from the Connecticut Department of Transportation (hereinafter "department") to operate motor vehicles in the transportation of household goods for hire, as a household goods carrier, over irregular routes between all points in Connecticut from a headquarters in Enfield.

B. Hearing Held

Pursuant to Connecticut General Statutes Section 13b-390, a hearing was to be held on this application at the administrative office of the Department, in Newington, Connecticut, on November 17, 2016. This is a rescheduled hearing from August at which the applicant also did not appear.

Notice of the application and of the hearing to be held thereon was given to the applicant and to other parties as required by Connecticut General Statutes Section 13b-390. Notice to the public was given by publication on the department's website.

The matter was assigned to a hearing officer designated by the Commissioner of Transportation pursuant to Connecticut General Statutes Section 13b-17.

C. Appearances


