The records of the department indicate you are the holder of motor bus Permit No. 550. The records of the department further indicate that you are in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies:

CGS Sections 13b-80, 13b-86, 13b-88, 4-182 and state agency regulations, as amended, by violating the terms of the permit which require the permit holder to comply with all pertinent motor vehicle laws and other statutes, and/or rules, regulations and orders of the department.

More specifically, on or about April 19, 2018, it came to the attention of the department that Concierge Enterprises, LLC may be in violation of the following:

- DOT Regulations, Docket No. 8500:
- o Rule No. 10 Inspection by Commission
- o Rule No. 13 Memorandum of Certificates
- o Rule No. 14 Fleet Registration
- o Rule No. 49 Identification Sign
- o Rule No. 50 Seating Capacity Display
- o Rule No. 51 Emergency Door
- Regulatory and Compliance Policy:
- o Mandatory Safety Equipment (Luggage barrier, triangles, fire extinguishers, first aid kits)
- Connecticut General Statutes:
- o Sec 13b-83 Registration of Motorbuses (Improper plates, No inspections)
- o Sec 14-29 Insurance Requirements (No Insurance)
- o Sec 14-34A Reciprocal agreements apportioning the registration of commercial vehicles (Reciprocity Sticker)

In addition, Sergeant Matthew Davis from The Connecticut Department of Motor

Vehicles, Office of Safety and Enforcement, provided a roster of vehicles in which allegedly were being used to provide unauthorized and improper inter and intra motorbus services, and which may or may not be related to Permit No. 550. In addition, you are subject to a hearing and a fine pursuant to CGS 4-182, 13b-80, 13b-85, and 13b-89(b).

Pursuant to Connecticut General Statute Section 4-182, as amended, you are hereby directed to appear at the office of the Department of Transportation Administrative Law Unit, 2800 Berlin Turnpike, Newington, Connecticut 06131, on November 27, 2018 at 10:00 AM, Hearing Room A, for a show cause hearing as to why this permit should not be revoked, suspended and/or the imposition of a civil penalty for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.
