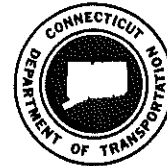

Notice is hereby given that a public hearing will be held by the Bureau of Finance and Administration, 2800 Berlin Turnpike, Newington, Connecticut, on October 1, 2019 at 10:00 AM and 10:30 AM in Conference Room A on Docket No. 1906-N-75-L & 1906-N-80-L for the applications of New Horizons Inc. dba New Horizons Village and New Horizons Inc. dba Sunshine Wheels.

Pursuant to the provisions of Sections 13b-103 and 4-177 through 182 of the Connecticut General Statutes (C.G.S.) New Horizons Inc. dba New Horizons Village seeks authorization to operate three (3) motor vehicles in general livery service, having a seating capacity of less than eleven (11) passengers, from a headquarters in Farmington.

Pursuant to the provisions of Sections 13b-103 and 4-177 through 182 of the Connecticut General Statutes (C.G.S.) New Horizons Inc. dba Sunshine Wheels seeks authorization to operate one (1)

motor vehicle in general livery service, having a seating capacity of less than eleven (11) passengers, from a headquarters in Farmington.

Pursuant to Section 4-177a of the Connecticut General Statutes, any person may request party status, if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's legal rights, duties or privileges shall be specifically affected by the agency's decision in the contested case.

In addition, any person may request intervenor status if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's participation is in the interests of justice and will not impair the orderly conduct of the proceedings.

All petitions for party or intervenor status must be submitted in written form and received by this department no later than five (5) days prior to the date of hearing. Otherwise, such requested status shall be subject to denial. The five-day requirement may be waived at any time before or after the commencement of the hearing on a showing of GOOD CAUSE. Copies of any requests for party or intervenor status must be mailed to the applicant and to all known parties.

An original and **FOUR (4) COPIES** of all prepared documents and exhibits intended to be introduced as evidence in this matter by the applicant, party, or intervenor must be filed with the department no less than **SEVEN (7) DAYS** prior to the date of hearing. All filings must be mailed to:
