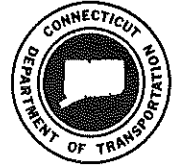

The records of the Department of Transportation, Regulatory and Compliance Unit (department) indicate you are the holder of Permit No. 2884. The records of the department further indicate that you are in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies (RCSA) CGS Section 13b-102, 13b-103, 13b-106 as amended, by violating the terms of the Permit which require the Permit holder to comply with all pertinent motor vehicle laws and other statutes, and/or rules, regulations and orders of the department.

More specifically:

1. On November 13, 2019, the Department was informed that insurance coverage for Daniel Ferjuste, who drives under the authority of your company, reduced his insurance liability limits, this is a direct violation of Connecticut General Statutes Section 14-29(f).

2. On February 19, 2020, the department was informed that Daniel Ferjuste, who drives under the authority of OnTime Limousine, LLC reduced his insurance liability limits for a second time, this time with Progressive Insurance Co. directly (not through an agent), this is a direct violation of Connecticut General Statute Section 14-29(f).

Pursuant to Connecticut General Statutes Section 13b-96, as amended, you are hereby directed to appear at the office of the Department of Transportation, 2800 Berlin Turnpike, Newington, Connecticut 06111, Hearing Room No. A for a show cause hearing as to why this permit should not be revoked, suspended and/or a civil penalty imposed for failure to comply with the applicable

be revoked, suspended and/or a civil penalty imposed for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.

Pursuant to Section 4-177a of the Connecticut General Statutes, any person may request party status, if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's legal rights, duties or privileges shall be specifically affected by the agency's decision in the contested case.

In addition, any person may request intervenor status if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's participation is in the interests of justice and will not impair the orderly conduct of the proceedings.

All petitions for party or intervenor status must be submitted in written form and received by this department no later than five (5) days prior to the date of hearing. Otherwise, such requested status shall be subject to denial. The five-day requirement may be waived at any time before or after the commencement of the hearing on a showing of GOOD CAUSE. Copies of any requests for party or intervenor status must be mailed to the applicant and to all known parties.

An original and **FOUR (4) COPIES** of all prepared documents and exhibits intended to be introduced as evidence in this matter by the applicant, party, or intervenor must be filed with the department no less than **SEVEN (7) DAYS** prior to the date of hearing. All filings must be mailed to:
