The records of the Department of Transportation, Regulatory and Compliance Unit (department) indicate you are the holder of Permit No. 2956. The records of the department further indicate that you are in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies (RCSA) CGS Section 13b-102, 13b-103, 13b-106 as amended, by violating the terms of the permit which require the permit holder to comply with all pertinent motor vehicle laws and other statutes, and/or rules, regulations and orders of the department.

More specifically:

It has come to the department's attention on November 21, 2019, that on or about January 18, 2019, a driver was involved in an accident while carrying a wheelchair passenger. Further, as a result of the accident, the passenger died on January 28, 2019. Upon review, the department finds your company is in direct violation of the following Statutes and Regulations:

- 1. CGS 14-36 (c) and Regulation 16-325-6 Failure to have proper commercial driver's license endorsement
- 2. CGS 14-29(f) Lack of Insurance
- 3. CGS 14-100(e)(1) and (2) Failure to properly secure wheelchair passenger
- 4. CGS 13b-102(b) Operating Authority from the FMCSA, address not updated

5. CGS 13b-103(b) – Suitability of the company

Pursuant to Connecticut General Statutes Section 13b-96, as amended, you are hereby directed to appear at the office of the Department of Transportation, 2800 Berlin Turnpike, Newington, Connecticut 06111, Hearing Room No. A for a show cause hearing as to why this permit should not be revoked, suspended and/or a civil penalty imposed for failure to comply with the applicable provisions of the Connecticut General Statutes and/or Regulations of Connecticut State Agencies, as stated above.

Pursuant to Section 4-177a of the Connecticut General Statutes, any person may request party status, if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's legal rights, duties or privileges shall be specifically affected by the agency's decision in the contested case.

In addition, any person may request intervenor status if such person has submitted a written petition to the agency and mailed copies to all parties, at least five (5) days before the date of the hearing and the petition states facts that demonstrate that the petitioner's participation is in the interests of justice and will not impair the orderly conduct of the proceedings.

All petitions for party or intervenor status must be submitted in written form and received by this department no later than five (5) days prior to the date of hearing. Otherwise, such requested status shall be subject to denial. The five-day requirement may be waived at any time before or after the commencement of the hearing on a showing of GOOD CAUSE. Copies of any requests for party or intervenor status must be mailed to the applicant and to all known parties.

An original and **FOUR (4) COPIES** of all prepared documents and exhibits intended to be introduced as evidence in this matter by the applicant, party, or intervenor must be filed with the department no less than **SEVEN (7) DAYS** prior to the date of hearing. All filings must be mailed to:

The meeting facility is ADA accessible.
