DECISION

MAY 17, 2021

I. INTRODUCTION

A. General

By citation dated March 25, 2021, by the Department of Transportation (hereinafter "department"), pursuant to Connecticut General Statutes Section 13b-410b as amended, ICARE MOVING, LLC ("respondent"), holder of Certificate Number 1798, was ordered to participate in a telephone citation hearing scheduled for May 13, 2021.

The records of the department indicate that the respondent is the holder of Household Goods Carrier Certificate Number HG1798. The records of the department further indicate that the respondent is in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies:

Connecticut General Statutes Sections 13b-410b (Payment of annual fees for filling proof of insurance by motor carriers) & Sec. 13b-410c (Intrastate household goods carrier certificate) and Regulations of Connecticut State Agencies Sections 16-304-F24 (List of Vehicles operated) and 16-304-D1 (Insurance required), as amended, by violating the terms of the certificate which require the certificate holder to comply with all pertinent laws and other statutes, and/or rules, regulations and orders of the department.

More specifically, on January 1, 2021, it came to the attention of the department that the respondent did not renew its Household Goods Carrier Certificates, did not provide a list of vehicles operated, and did not provide a form E proof of insurance. As a result, the respondent was subject to a citation hearing and a fine of \$500.00 pursuant to Connecticut General Statutes Sections 13b-414 and 13b-407 along with possible revocation of its certificate.

The citation was served upon the respondent at 90 Brainard Road, Suite 105. Hartford. Connecticut 06114 by certified mail and recited the department's reasons for issuing it.

B. Hearing Held

Pursuant to Section 13b-414 and 13b-407 of the Connecticut General Statutes, as amended, the public telephone hearing for this citation was held on May 13, 2021. Notice of the citation and the hearing to be held thereon was given to the respondent and to such other parties as required by Connecticut General Statutes Sections 13b-414 and 13b-407, as amended.

The hearing on this matter was conducted by a hearing officer designated by the Commissioner of Transportation, pursuant to Section 13b-17 of the Connecticut General Statutes.

C. Appearances

Cortney Dunlap appeared pro se on behalf of the respondent. The respondent's new mailing address is 122 Nelson Drive, Burlington, Connecticut 06013.

II. FINDINGS OF FACT

- 1. The respondent is the holder of Certificate 1798 standing in the name of ICARE MOVING, LLC.
- 2. The respondent dissolved the business when he lost a contract with the State of Connecticut.

3. On May 13, 2021, Mr. Dunlap emailed the department that he was voluntarily surrendering his household goods authority Certificate Number 1798.

III. DEPARTMENT ANALYSIS AND CONCLUSIONS OF LAW

The Department of Transportation has jurisdiction over matters pertaining to the operation of motor vehicles in household goods service in the State of Connecticut accordance with Connecticut General Statutes Section 13b-414 and 13b-407, as amended.

Pursuant to Connecticut General Statutes Section 13b-407 and 13b-414, the department may amend or for sufficient cause suspend or revoke any such permit. Further, the department may impose a civil penalty on any person who violates any provision of the governing chapter or any regulation adopted under Connecticut General Statutes Section 13b-389 through 13b-415, as amended, with respect to fares, service, operation or equipment, in an amount not to exceed one hundred dollars per day for each violation.

The respondent has notified the department that he is no longer in business and has voluntarily surrendered Certificate Number 1798 by email on May 13, 2021.

IV. ORDER

Based on the above, the citation will be dismissed as Certificate 1798 has been voluntarily surrendered by the respondent.

This decision constitutes notice in accordance with Connecticut General Statutes Section 4-182(c).
