RE: APPLICATION OF IQ TRANSPORTATION LLC TO OPERATE ONE (1) MOTOR VEHICLE IN GENERAL LIVERY SERVICE, WITH A SEATING CAPACITY OF LESS THAN ELEVEN PASSENGERS, FROM A HEADQUARTERS IN STAMFORD

**DECISION** 

**JANUARY 10, 2023** 

#### I. INTRODUCTION

# A. APPLICATION

By application filed on November 9, 2022, with the Department of Transportation (hereinafter "department"), pursuant to Section 13b-103 of the Connecticut General Statutes, as amended, IQ Transportation LLC (hereinafter "applicant") with a mailing address of 520 Hope Street, Stamford, Connecticut 06906 seeks authorization to operate one (1) motor vehicle, having a seating capacity of less than eleven (11) passengers, in general livery service from a headquarters in Stamford.

# B. HEARING

Pursuant to Connecticut General Statutes Section 13b-103, as amended, a public hearing by telephone was held on this application on January 4, 2023.

Notice of the application and of the hearing to be held thereon was given to the applicant and to such other parties as required pursuant to Connecticut General Statutes Section 13b-103, as amended. Legal notice to the public was given by publication on the department's website.

A hearing officer designated by the Commissioner pursuant to Connecticut General Statutes Section 13b-17 conducted the hearing on this matter.

#### C. APPEARANCES

Hassnain Waheed appeared pro se on behalf of the applicant. The applicant's mailing address is 520 Hope Street, Stamford, Connecticut 06906.

#### II. FINDINGS OF FACT

- 1. The applicant seeks to operate one (1) motor vehicle in general livery service from a headquarters in Stamford.
- 2. The applicant proposes to operate a 2023 Cadillac XT6 SUV. This vehicle is financed.
  - 3. The livery insurance has been paid for the entire year.
  - 4. The applicant has been operating in interstate livery service since 2018.
  - 5. The applicant's first six months of expenses includes vehicle financing of \$6,392

- 6. and property tax of \$503. There are no additional expenses the applicant needs to incur to start intrastate livery service.
  - 7. The applicant has \$8,521 in a business bank account.
- 8. The applicant has several part-time employees who will drive the livery vehicle in addition to himself.
  - 9. The applicant will be operating the livery business out of his residence.
- 10. The applicant wants to expand his interstate livery business to include intrastate livery transportation as he has received many requests for this service.
  - 11. This application was not opposed.

#### III. DISCUSSION

The department has jurisdiction over each person, association, limited liability company or corporation owning or operating a motor vehicle in livery service, pursuant to Connecticut General Statutes Section 13b-102, as amended.

In determining whether a livery permit should be granted, the department shall take into consideration the present or future public convenience and necessity. The applicant must prove that the public's convenience and necessity will be improved by the proposed service. Additionally, the applicant must show the suitability of the applicant or the suitability of the management if the applicant is a limited liability company or corporation, the financial responsibility of the applicant, the ability of the applicant efficiently and properly to perform the service for which authority is requested and the fitness, willingness and ability of the applicant to conform to the provisions of the statutes and the requirements and regulations of the department thereunder, in accordance with Connecticut General Statutes Section 13b-103.

Regarding the applicant's suitability, the applicant submitted a criminal record check for Hassnain Waheed which disclosed no criminal record. The applicant operates multiple business including a Subway restaurant and an ice cream shop. The applicant also has operated an interstate livery business since 2018. Based on the evidence presented, the applicant is suitable to conduct the proposed intrastate livery business.

As far as the applicant's financial ability is concerned, the applicant presented evidence that the first six months of expenses includes vehicle financing of \$6,392 and property tax of \$503 for a total expense of \$6,895. The applicant has \$8,521 in a bank account to cover these startup expenses and is therefore financially suitable.

The applicant has been operating in interstate livery service since 2018 and he receives many requests for intrastate livery transportation. Based on the evidence presented, the applicant has shown that public convenience and necessity will be improved by a grant of this application.

#### IV. ORDER

Based upon the above and pursuant to Connecticut General Statute Section 13b-103, as amended, the application in the name of IQ Transportation LLC is hereby granted, and Livery Permit Number 3511 is hereby reissued as follows:

#### **LIVERY PERMIT NUMBER 3511**

IQ Transportation LLC is authorized to operate one (1) motor vehicle in general livery service, with a seating capacity of less than eleven passengers, from a headquarters in Stamford.

IQ Transportation LLC is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-938668-C.

#### **RESTRICTIONS:**

The applicant must register and insure the one (1) general livery vehicle granted in this decision within ninety (90) days. Failure to do so may result in revocation of the general livery authority.

The authority granted under this permit may not be sold or transferred until it has been operational, i.e. a vehicle registered with livery plates thereunder for not less than twenty-four (24) months.

This permit shall remain in effect until it is amended, suspended or revoked by the department. Failure of the permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other state statutes and/or rules, regulations and orders of the department shall be considered sufficient cause to amend, suspend or revoke said permit.

A memorandum of this permit, bearing the seal of the department, shall be
