



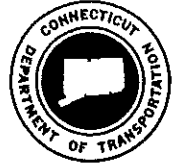

The records of the Department of Transportation (Department) indicate you are the holder of Livery Permit Number 3550. The records of the department further indicate that you are allegedly in violation of the following Connecticut General Statutes (CGS) and/or Regulations of Connecticut State Agencies:

- CGS Sections 13b-103(b): Suitability

The alleged incident at question violates the terms of the permit, which require the permit holder to comply with all pertinent laws and other statutes, and/or rules, regulations, and orders of the department.

More specifically, on November 28, 2023, the department received a complaint that alleges you have not compensated former employee, Richard Ciuizio, for two separate trips that he completed as a driver under your livery permit. Originally, the dates of these jobs were reported as of 07/19/23 and 07/29/23, but the first date of the 19th was later corrected and verified to be 08/07/23. The alleged unwillingness to compensate your contracted driver for work performed under your authority, raises the question of your suitability to hold a permit.


As a result of the alleged violations, you are subject to a telephone citation hearing pursuant to CGS 13b-103, and you are subject to a penalty pursuant to CGS 13b-108 in accordance with CGS 4-182. You are hereby directed to appear at a telephone citation hearing on February 28, 2024, at 10:00 AM for a Show Cause hearing as to why this Certificate should not be revoked, suspended, and/or imposed a civil penalty for failure to comply with the applicable provisions of the Connecticut General Statutes and Regulations of Connecticut State Agencies, as stated above.
