Questions and Answers Session:

The following are the questions and comments submitted by the public and stakeholders, along with their respective responses, organized into subject matter categories for ease of review.

Construction

- **What are the limits of Construction?**
 - The design team shared a graphic of the design limits using CAD software and outlined the full limits of construction. These limits include I-95 from West Avenue to Washington Boulevard. The following ramps are also within the project limits: The I-95 NB Exit 6 on-ramp and Exit 7 off-ramp, and the I-95 SB Exit 7 on-ramp and Exit 6 off-ramp.
- **How long is construction anticipated to last?**
 - The design team responded that the early estimate for construction duration is 2 years. Once the contractor team is selected and the design is finalized, the construction duration will be finalized.
- **Will there be any detours?**
 - The design team stated that there are no detour agreements in place at this time, however, once the design is finalized the contractor will only be allowed to utilize detours during off-peak periods and all ramps must be open before the morning commute.

Design

- **Are you proposing any improvements to the ramps at Exit 6 and/or 7?**
 - The design team stated that the scope of improvements for ramps includes roadside safety updates as well as illumination, concrete pavement repairs, and drainage improvements. The limits of construction will end at the termini of the ramps and not extend into the local roads.
- **Is there any work on local streets?**
 - The design team stated that the limits of construction will end at the termini of the ramps and not extend into the local roads. Some minor improvements in the near vicinity of the termini will include some ADA sidewalk ramp improvements, striping, and some minor pedestrian accommodation improvements.
- **Is there any proposed work on top of the Wilson Street and Fairfield Avenue Bridges?**
 - The design team displayed a graphic of the bridges using cad software and outlined the work being done. It was explained that the work primarily focuses on the underside of the structures for maintenance and any work required to construct the widened highway section. GM2 also mentioned that if there was work needed on joints on the top side
