APPLICATION OF SAFE TRANSPORTATION LLC HOLDER OF LIVERY PERMIT NO. 2206, TO TRANSFER HEADQUARTERS FROM PLAINVILLE TO NEWINGTON,

I. APPLICANT'S PROPOSAL

By application 2002-TH-19-L filed on February 13, 2020, pursuant to Section 13b-103 of the Connecticut General Statutes (C.G.S.), Safe Transportation LLC (hereinafter "applicant"), holder of Livery Permit Number 2206, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its Plainville headquarters to Newington, and close the Plainville headquarters. Specifically, to transfer:

1. Sixteen (16) motor vehicles with a passenger capacity of ten (10) adults or less in general livery service. Granted pursuant to Docket # 2005-S-30-L on May 18, 2020.

II. DEPARTMENT ANALYSIS

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

III. FINDINGS OF FACT

- 1. The applicant has submitted the proper application before this department.
- 2. After a Records check, the Department finds that the applicant's records indicate that it maintained insurance on all of its registered vehicles.
- 3. No opposition was filed by existing operators in the headquarters town.

IV. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103, the instant application, given Application Number 2002-TH-19-L, filed by Safe Transportation, LLC, is approved and Livery Permit Number 2206 is amended and reissued as follows:

LIVERY PERMIT NUMBER 2206 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Safe Transportation, LLC is hereby permitted to operate sixteen (16) motor vehicles with a passenger seating capacity of ten (10) adults or less in general livery service to all points in Connecticut from a headquarters in Newington, granted pursuant to Docket # 2005-S-30-L on May 18, 2020.

RESTRICTIONS:

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department.

A memorandum of the permit bearing the seal of the Department shall be kept conspicuously posted in the motor vehicles operated hereunder.
