## I. APPLICANT'S PROPOSAL

By application 2006-TH-34-L filed on June 8, 2020, pursuant to Section 13b-103 of the Connecticut General Statutes (C.G.S.), Alliance Global Associates, LLC (hereinafter "applicant"), holder of Livery Permit Number 3486, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its Stamford headquarters to Fairfield, and close the Stamford headquarters. Specifically, to transfer:

1. Four (4) motor vehicles with a passenger capacity of ten (10) adults or less in general livery service from a headquarters in Stamford. Granted pursuant to Docket # 1811-AVWO-137-L on April 16, 2019.

## II. DEPARTMENT ANALYSIS

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

## III. FINDINGS OF FACT

1. The applicant has submitted the proper application before this Department.
2. The Department finds that the applicant's records indicate all its vehicles have been in use and are available for transfer.
3. No opposition was filed by existing operators in the headquarters town.

## IV. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103, the instant application, given Application Number 2006-TH-34-L, filed by Alliance Global Associates, LLC, is approved and Livery Permit Number 3486 is amended and reissued as follows:

### **LIVERY PERMIT NUMBER 3486** **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Alliance Global Associates, LLC is hereby permitted to operate four (4) motor vehicles with a passenger seating capacity of ten (10) adults or less in general livery service to all points in Connecticut from a headquarters in Fairfield, granted pursuant to Docket # 1811-AVWO-137-L on April 16, 2019


In addition, American Livery Service, Inc. is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-905981-C.

**RESTRICTIONS:**

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

A memorandum of the permit bearing the seal of the Department shall be kept conspicuously posted in the motor vehicles operated hereunder.
