**INTRODUCTION**

By application filed on August 18, 2020, with the Connecticut Department of Transportation (hereinafter "Department"), Golden Years Homemakers & Companions LLC. (hereinafter "applicant") has re-entitled its authority to Golden Years Homemakers & Companions Inc. Therefore, Livery Permit Number 3694 is amended and re-issued as follows:

**LIVERY PERMIT NO. 3694**

**FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Golden Years Homemakers & Companions Inc. is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes, as amended, to operate one (1) motor vehicle, having a passenger seating capacity of eleven (11) or less adults, in General Livery Service between all points in Connecticut from a headquarters in Plainville.

The authority granted under this permit may not be sold or transferred until it has been operational, i.e. a vehicle registered with livery plates thereunder for not less than twenty-four (24) months.

This Permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the Permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State Statutes and/or the rules regulations and order of the Department shall be considered sufficient cause to amend, suspend or revoke this permit. This Permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be re-registered and re-issued in the new name within thirty (30) days of the date of this Decision.**

A memorandum of this permit, bearing the seal of the department, shall be kept conspicuously posted in each motor vehicle operated under this permit.
