APPLICATION NO. 2012-RE-72-HG RE-ENTITLEMENT OF AUTHORITY OF TAIT TRANSPORTATION, LLC DBA TAIT MOVING AND STORAGE TO TAIT TRANSPORTATION, LLC DBA COLONIAL MOVING AND STORAGE

INTRODUCTION

By application filed on December 15, 2020, and assigned Application No. 2012-RE-72-HG, Tait Transportation, LLC dba Tait Moving and Storage (hereinafter "applicant), holder of Certificate No. HG1794 seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to re-entitle its name to Tait Transportation, LLC dba Colonial Moving and Storage. Therefore, Certificate Number HG1794 is amended and re-issued as follows:

CERTIFICATE NO. HG1794 TO OPERATE MOTOR VEHICLES FOR THE TRANSPORTATION OF PROPERTY FOR HIRE AS A MOTOR COMMON CARRIER

Tait Transportation, LLC dba Colonial Moving and Storage is hereby permitted and authorized, subject to such regulations and conditions as the Department may from time to time prescribe, to transport property for hire as a motor common carrier over irregular routes as follows:

Household goods, within the State of Connecticut, between all points upon calls received at its headquarters in Berlin.

The certificate holder must accept and transport property, as herein authorized in accordance with its tariff on file, for all persons who desire the service to the extent of the Certificate Holder's facilities at uniform rate for all similar service.

Tait Transportation, LLC dba Colonial Moving and Storage is also hereby authorized in interstate commerce by the issuance of MC-84884-C by the Federal Motor Carrier Safety Administration.

CONDITIONS:

A motor vehicle must be registered under this certificate within sixty (60) days from the date of this decision.

There shall be carried in each vehicle operated under this authority a copy of the certificate of registration receipt by the Department.

This Certificate shall remain in effect until suspended, amended or revoked by the Department. Failure of the Certificate Holder to maintain proper insurance or to comply with all motor vehicle laws and other pertinent State statutes and/or the rules, regulation and orders of the Department shall be considered sufficient cause to revoke said certificate.

This certificate may not be sold or transferred until it has been operational for more than twenty-four (24) months.

This certificate is transferable only with the approval of the Department and is issued subject to compliance by the holder thereof with all motor vehicle laws of the State of Connecticut, and with such rules regulations and orders as this Department may from time to time prescribe.
