I. INTRODUCTION

Hunter Limousines LTD of Connecticut, Inc. dba Hunter Limousine LTD (hereinafter “transferor”), is the holder of Livery Permit No. 2212, last issued by the Department of Transportation (hereinafter “Department”) on January 15, 2003 authorizing the operation of:

1. SEVEN (7) motor vehicles, each having a passenger seating capacity of ten (10) passengers or less, in general livery service from a headquarters in Middletown.
2. BUS type motor vehicles, each having a passenger seating capacity of ten (10) passengers or less, in general livery service, from a headquarters in Middletown.
3. EIGHTEEN (18) motor vehicles, each having a passenger seating capacity of ten (10) adults or less in general livery service from a headquarters in Meriden.
4. FOUR (4) motor vehicles for the provision of livery service under contract with or lower tier contract for, any federal, State, or municipal agency from a headquarters in Middletown.

Hunter Limousines LTD. Of Connecticut, Inc. dba Hunter Limousines LTD is further permitted and authorized to operate motor vehicles for the transportation of passengers in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of certificate No. MC-238690.

Liberty Limousine Service, LLC (hereinafter “transferee”), is the holder of Livery Permit No. 2461, last issued by the Department of Transportation (hereinafter “Department”) on March 21, 2007 authorizing the operation of:

1. SIXTEEN (16) motor vehicles, each having a passenger seating capacity of ten (10) passengers or less in general livery service from a headquarters in Meriden.

Liberty Limousine Service, LLC is further permitted and authorized to operate motor vehicles as a common carrier of passengers in charter and special operations in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate No. MC-211312.

II. APPLICANTS' PROPOSAL

By joint application filed on May 10, 2021 and given Application No. 2105-S-37-L, the applicants seek Department approval of the sale and transfer of the authority granted under Livery Permit No. 2212 from the transferor to Liberty Limousine Service, LLC (hereinafter “transferee”).

III. FINDINGS OF FACT

1. The applicants have submitted the proper application before the Department.
2. After a review of the transferor’s records, it was determined that 12 of the 18 vehicles in general livery service from a headquarters in Meriden are registered. The remaining 6 vehicles are not registered, not compliant, and therefore revoked at time of sale.

3. The transferee voluntarily revoked all authority in their Middletown headquarters per email from Danielle Vailonis, POA and Paralegal for transferee, per email on May 10, 2021.

4. The transferee is financially able to staff, equip and operate the livery service transferred herein.

5. The required Criminal Conviction History Report (CCHR) was filed with the application.

6. The Purchase Agreement was submitted with the application.

7. Proof of sufficient insurance coverage for the transferee was submitted with the application.

IV. CONCLUSION

The transferee retains its current name, Liberty Limousine Service, LLC and Livery Permit No. 2461 for that authority.

The transferee concurrently takes on the transferor's name, Hunter Limousines LTD. Of Connecticut, Inc. dba Hunter Limousine LTD and Livery Permit No. 2212 for that authority. The transferor hereby revokes all authority associated with Permit No. 2212.

Therefore, based upon the facts stated above, and pursuant to section 13b-103, the Department hereby approves the sale and transfer of the authority granted under the transferor's livery permit as proposed, to the transferee. Following the approval of this sale and transfer, the transferor will retain no rights to the authority transferred and Livery Permit Number 2212, held in the name of Hunter Limousines LTD. of Connecticut dba Hunter Limousine LTD. is hereby amended and reissued in the following form:

LIVERY PERMIT NO. 2212 **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Hunter Limousines LTD. of Connecticut dba Hunter Limousine LTD. is hereby permitted and authorized, in accordance with and under the provisions of the General Statutes, as amended, to operate:

1. TWELVE (12) motor vehicles in general livery service, each having a passenger seating capacity of ten (10) adults or less, from a headquarters in Meriden.

Hunter Limousines LTD. Of Connecticut, Inc. dba Hunter Limousines LTD is further permitted and authorized to operate motor vehicles for the transportation of passengers in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of certificate No. MC-238690.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

The authority transferred may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application (2105-S-37-L), the authority granted herein will be revoked.

This permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

LIVERY PERMIT NO. 2461
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Liberty Limousine Service, LLC is hereby permitted and authorized to operate Sixteen (16) motor vehicles, each having a passenger seating capacity of ten (10) adults or less in general livery service from a headquarters in Meriden.

Liberty Limousine Service, LLC is further permitted and authorized to operate motor vehicles as a common carrier of passengers in charter and special operations in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate No. MC-211312.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department.

This permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicles operated hereunder.
