I. INTRODUCTION

Shalom Limo, LLC (hereinafter “transferor”), is the holder of Livery Permit No. 3655 last issued by the Department of Transportation (hereinafter “Department”) on March 15th, 2019, authorizing the operation of:

1. One (1) motor vehicle, having a passenger seating capacity of eleven (11) adults or less, in general livery service between all points in Connecticut from a headquarters in West Hartford.

II. APPLICANTS' PROPOSAL

By joint application filed on June 6th, 2022 and given Application No. 2206-S-63-L, the applicants seek Department approval of the sale and transfer of the authority granted under Livery Permit No. 3655 from the transferor to Trusted Limo LLC (hereinafter “transferee”).

III. FINDINGS OF FACT

1. The applicants have submitted the proper application before the Department.
2. After a review of the transferor’s records, it was determined that all the vehicles are registered.
3. The transferee is financially able to staff, equip and operate the livery service transferred herein.
4. The required Criminal Conviction History Report (CCHR) was filed with the application.
5. Proof of sufficient insurance coverage for the transferee was submitted with the application.

IV. CONCLUSION

The transferee retains its current name and takes on the transferor’s livery permit number and authority.

Therefore, based upon the facts stated above, and pursuant to section 13b-103, the Department hereby approves the sale and transfer of the authority granted under the transferor’s livery permit as proposed, to the transferee. Following the approval of this sale and transfer, Shalom Limo, LLC will retain no rights to the authority transferred and Livery Permit Number 3655, held in the name of Shalom Limo, LLC is hereby amended and reissued in the following form:

LIVERY PERMIT NO. 3655
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Trusted Limo LLC, is hereby permitted and authorized, in accordance with and under the provisions of the General Statutes, as amended, to operate:

1. One (1) motor vehicle, having a passenger seating capacity of eleven (11) adults or less, in general livery service between all points in Connecticut from a headquarters in West Hartford.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

The authority transferred may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 2206-S-63-L, the authority granted herein will be revoked.

This permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicles operated hereunder.
