#### 2.0 Old Business

- 2.1 Complete Streets Policies
  - a. Development of recommendations for institutionalization of Complete Streets Policies

No report from ConnDOT, although CS Policy by CTBPAB was to be conveyed to the commissioner via Tom Maziarz.

Review Sandy's letter draft to Commissioner, suggested revisions to letter.

Commissioner issued a complete streets summary report. Browse on the website. Changes not likely to be required, but cover letter should be revised.

Kate comments on 4.4.2, give source for percentage, 4.4.3 remove reference to local aid road program – (this is not a discretionary program), 6.2 percentage – footnote the 20% and reference.

Need to elicit comments from Tom Maziarz.

Cover letter edits required.

## Motion

To approve the CS policy with the changes discussed with Kate Rattan. Motions passed with unanimous approval by the board members present.

Cover letter revisions - email comments to Sandy.

The Board needs to review DOT report, but based on initial review at the meeting, it appears to complement the work of the Board on the CS Policy draft.

2.2 Update of Bicycle Pedestrian Needs Assessment Form (ver. 2.0 7-3-13)

New form implemented and training for staff. DOT willing to accommodate CTBPAB member at training session.

- 2.3 Review of other action steps
  - a. Outreach to CT Department of Motor Vehicles with recommended language for drivers manual and drivers licensing exam pertaining to cyclists

Board reviewed letter, delete 3 and 4<sup>th</sup> paragraphs and put "ask" in there for requesting that someone at DMV be designated to work with the CTBPAB. Board endorsed the revised letter to be transmitted to DMV.

b. Outreach to Chief Elected Officials for Complete Streets implementation at the local level

Revise letter (JCB), modify website to add links. Members should send charlie links to complete streets resources to be posted to the website.

c. Discuss with SWRPA & HVCEO regional mobility mapping/ development of cross state bike routes that include local roads and transit opportunities – **Pending (Ray).** 

Bike study last done in 1996 for HVCEO.

Kate indicated that ConnDOT plans to develop a new bike map (they are almost out of all printed copies of the earlier map) and the software for developing that map is no longer available. They may revise the criteria as presented in the online bike map (ctbikemap.org) to include more than shoulder width and ADT.

New mapping would be both online and printed copy.

d. Inventory State Routes changed to 11 foot lanes

Pending. Total miles is available in Commissioners report. Include that in the annual report.

e. Determination of sources for entry of transit into Google Maps



All CT Transit routes have provided google feed for entire CT Transit systems (8 of them). Smaller systems have not as it is a lot of maintenance for small systems.

f. AMTRAK – Prohibition of bikes on trains

Letter revisions are pending.

CRCOG and GHTD are working together to promote regional bike share. The initial focus is on CTfastrak and the commuter rail corridor. They plan to issue an RFP for a feasibility analysis. They hope to develop regional contract, which municipalities could join.

g. Letters of recognition for Complete Street initiatives **Not required.** 

h. Presentations to other organizations to promote Complete Streets **Reach out to CCM for presentation and notification to municipalities (JCB).**
