2.1 DOT Projects and News

Active Transportation plan – few more changes being considered by the commissioner and then issued to steering committee before being released to public by end of 2018. The final plan will be \sim 25 pages

Community Connectivity Program – 40 approved Towns. Meetings being scheduled for reviewing the rules with the Towns, since this is a new program. Towns may be grouped by Districts or Regions. Environmental review is ongoing internally at DOT

Response to the letter on the highway design manual from CTDOT? Matt Vale generated response – not received by the Board yet. DOT is working on restructuring the committee for the highway design manual revision. DOT is developing a scope for FHI to do three tasks: bike network evaluation, design guideline development, and interactive web site. The Board noted the value of having the ability to report issues on the interactive website.

It was noted that the DOT website is what it is and staff cannot impact it very much. DOT had misinterpreted Board meeting notes which discussed the need for a website overhaul, the Board was referring to the CTbikeped.org website, not DOT website
