documents for these. 5 of the 12 have been studied further or are in design, the remainder are being scoped. A Road Safety Audit (RSA) is planned for #7, Route 1 in Bridgeport.

Chip seal – pilot projects, status, results?

CTDOT visiting MassDOT to observe their applications for shoulders and possible utilization for 2022 program for new roads chip sealed with an overlay on shoulders for bike route roadways. Will make a decision soon for 2022 and will provide an update next month

Active Transportation Plan –mapping. Dave Elder reached out to the COGs and asked for members for a stakeholder group that will vet and review proposals for map changes. This will be similar to the group that oversaw the creation of the first map. The Board will also be invited to have a participant.

Gold star bridge – there will be three contracts for improvements to the bridge – the first, strengthening the truss span, needs to go out soon (October 6), so focus is on this. The second will be for strengthening the girder spans, and the final will be for replacement of the deck. It is in this final stage that a bike path might be designated on the north span. Progress with feasibility study of improving existing ped way – in June reported that this would be completed in September. Study is ongoing as focus has been on getting the first bridge project out to bid.

Community Connectivity grant program, update 90 grants awarded to date 16 constructed, 17 in construction, 8 in preconstruction \$8.5 million awarded to communities, \$21.9 million of projects outstanding Discussion of need for design \$ - SCCOG has selected an on call consultant for this purpose.

Vision Zero Council – no udate available, Anna will send Sandy an update via email. Joe noted that he attended the kickoff meeting of the Council. Members of the Council are all part of state government. There will be a subcommittee that allows broader public participation.

- 3.3 Implementation of bicycle plan: Ability of people to use bicycles for regular transportation need a strong focus on urban areas, and specifically safety

Making improvements for pedestrian safety will likely also help bikes and transit. Any city that is bicycle friendly is also walkable Focus on the pedestrian gaps, usually sidewalk/signal deficiencies Correcting the Fee in Lieu of Sidewalk (FILOS) issue could help. What is the role of the bike ped board in these initiatives? What recommendations we might include in our next annual report. Sidewalk inventories should be considered. It is hard for communities to get funding for planning. It took New Haven 4 years to put together funding for its Safe Routes for All plan. COGs can help but there is not sufficient funding for all planning needed. Could each town have a bike/ped contact? Need driver for regional facilities, starting with urban areas.

3.4 Speed camera initiative

Consider in the future legislation session? Board supports this.

Work zone pilot is in current legislation and should be in the implementer.

So far an uphill battle on speed zones. ACLU is strong anti, we don't have a strong champion organization. Roland Lemar brings it up each year, and this year it went the furthest ever. Issues are privacy, race and broad enforcement. It is important to get some conversations going to discuss these issues and allay concerns.
