The contract between Connecticut Food Bank, Inc. (the Contractor) and the Department of Social Services (the Department), which was last executed by the parties and approved by the Office of the Attorney General on 06/13/2016, is hereby further amended as follows:

- The total maximum amount payable under this contract is increased by \$352,724.00 from \$720,390.00 to \$1,073,114.00. This increase is due to the receipt of additional federal funding through the Emergency Food Assistance Program (TEFAP) for federal fiscal year 2017.
- The contract term shall be extended for an additional two (2) years from 09/30/2016 to 09/30/2018.
- 3. The budget on page 2 of amendment #1 is deleted and replaced by the budget on page 2 of this amendment.

All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.
