The contract between Foodshare, Inc. ("Contractor") and the Connecticut Department of Social Services ("Department"), which was last executed by the parties on 1/21/2015 is hereby amended as follows:

- 1. The total maximum amount payable under this contract is increased by \$20,100.00 from \$248,592.00 to \$268,692.00. The increase is due to receipt of increased federal funding through The Emergency Food Assistance Program (TEFAP) for federal fiscal year 2016.
- 2. The budget on page 12 of the original contract shall be deleted and replaced in its entirety by the budget on page 2 of this amendment.

3. All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.


