1. The total maximum amount payable under this contract is increased in the amount of \$1,300,000.00 from \$4,659,350.00 to \$5,959,350.00. The funds are to support services provided for SFY 2016. Preliminary expenditure projections were insufficient to meet ongoing and projected caseload and work component demand.


