The contract between **Thames Valley Council for Community Action, Inc.** and the Department of Social Services, which was last executed by the parties and signed by the Commissioner on 09/04/14, is hereby amended as follows:

1. The total maximum amount payable under this contract is increased by **\$47,357** from \$94,714 to \$142,071.
2. The budget on page 12 of the original contract is deleted and replaced in its entirety by the budget on page 2 of this amendment.
3. The term of the contract is extended for an additional six months and the end date of the contract is changed from 9/30/15 to 3/31/16.

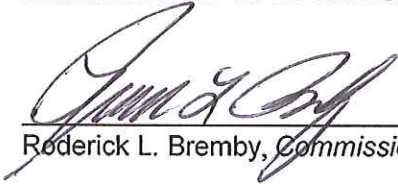
