The contract between Connecticut Coalition Against Domestic Violence, Inc. ("Contractor") and the Connecticut Department of Social Services ("Department"), which was last executed by the parties and approved by the Office of the Attorney General on 10/3/2012, and previously amended on 10/7/2013, 4/29/2014, 7/30/2014, 10/6/2015, and 5/9/2017, is hereby further amended as follows:

- 1. The term of the contract is extended for an additional one (1) year and the end date of the contract is changed from 6/30/17 to 6/30/18.
- 2. The total maximum amount payable under the contract has increased by \$6,621,258 from \$30,774,763 to \$37,396,021 to provide funding for the extended term of the contract.
