

WHAT IS IT?

PREMIUM PAY

Payments to essential workers* that were on the job during the pandemic.

- Payments up to \$1,000 for full-time workers
- Payments up to \$500 for part-time workers
- NOT first-come, first-served
- Application deadline: October 1, 2022
- Total available: \$30 million

COVID-19 RELIEF FUND

Financial relief for essential workers* who got COVID-19, were unable to work, got sick or passed away.

- Covers unpaid leave or lost wages
- Covers out-of-pocket medical expenses due to COVID-19
- Provides \$3,000 burial assistance for workers that died from COVID-19
- Total available: \$34 million

* eligibility differs for each program

WHO IS ELIGIBLE?

PREMIUM PAY

- Essential worker in category 1A or 1B (1C workers are NOT included in Premium Pay)
- Worked in CT between March 10, 2020, and May 7, 2022
- NO COVID DIAGNOSIS NECESSARY
- Must have been working on a job site, unable to work from home
- Only for those who made under \$150k/yr
- Only for private sector workers, not for federal, state or municipal employees

COVID-19 RELIEF FUND

- Essential workers in categories 1A, 1B & 1C
- Resident of CT between March 10, 2020 and July 20, 2021
- Contracted COVID-19 between March 10, 2020 and July 20, 2021
- Lost wages due to the inability to work, or incurred out-of-pocket medical expenses after a COVID-19 diagnosis or related illness.
- Died as a result of COVID-19, after being diagnosed between March 10, 2020 and July 20, 2021.

PROGRAM BENEFITS

PREMIUM PAY

- Up to \$1,000 for qualified workers who earned less than \$100k/yr
- Up to \$500 for part-time workers
- Amounts gradually decrease for those who earned between \$100k - \$150k
- If demand exceeds the fund, payments will be adjusted proportionally so everyone gets the same treatment. You don't get more for applying early.

COVID-19 RELIEF FUND

Lost wages

- Amount equal to 75% of their average weekly pay for the number of days they were unable to work
- Up to \$1,400 per week

Out-of-pocket medical expenses

No limit

Burial expenses

Up to \$3,000

DEADLINES

PREMIUM PAY

Program is NOT first-come, first-served

Must apply by October 1, 2022

- Payments are taxable; recipients will receive a 1099 form
- Final payment calculations happen after application process closes on October 1, 2022

COVID-19 RELIEF FUND

Program IS first come, first served

Must apply by December 31, 2022

- Payments are not taxable
- Workers can apply for all relief categories

COVID-19 RELIEF FUND

Apply for both programs using the same web site. Eligible workers can apply for both funds.

Must provide documentation to verify identity and eligibility.

HOW TO HELP
