

In accordance with CGS §19a-639e and OHCA policies and procedures implementing Public Act 10-179, this letter serves as notice that HSC Community Services, Inc. d/b/a Special Care Dental Services will be terminating the provision of all dental services authorized under Docket Number 98-542. The outpatient dental clinic is located at 411 Osgood Avenue, New Britain, CT 06053, and will cease the provision of services as of December 16, 2012.

Special Care Dental Services has experienced a decrease in demand for services, which may be attributed to the increase in rates under the Medicaid Fee Schedule for dental services. The increase in those Medicaid rates has improved access to services at private dental practices. Also, the provision of services by school-based and community health center providers has increased access to dental care for pediatric patients in the local area. Therefore, the community need for which Special Care Dental Services was originally established is no longer a pressing concern. For these reasons, the Boards of Directors of HSC Community Services, Inc. and its parent entity, Center of Special Care, Inc. (CSC), have determined that the dental services at the outpatient pediatric clinic will be discontinued.

Hospital for Special Care (an affiliated provider of CSC) will continue to provide dental care on an inpatient and outpatient basis, and is currently evaluating its ability and the need to provide outpatient services for pediatric and adolescent patients, should current patients of Special Care Dental Services express the desire for continued treatment.

Several unaffiliated dentists and programs will continue to offer pediatric dental services, including:

- Kool Smiles 105 Myrtle Street, New Britain
- New Britain Community Health Center 85 Lafayette Street, New Britain
- Aspen Dental 8 locations within a 25 mile radius, and
- School-based and mobile dental services at local elementary schools, Roosevelt Middle School and New Britain High School.
