Re: 86 Boston Post Road/Termination of Service

Dear Ms. Martone:

On May 17, 2010, Stonington submitted a Form 2020 for the termination of outpatient services at 86 Boston Post Road, Waterford, CT ("86 BPR").

On May 27, 2010, OHCA notified Stonington via letter that a CON for the termination was necessary.

On June 14, 2010, OHCA notified Stonington that a public notice had been published and that the window for submitting the Application in this matter would open on July 26, 2010 and close on September 24, 2010.

During the same time period, OHCA was in receipt of LOI applications for termination of service at three other locations: 83 Boston Post Road, Waterford; 37 Commerce Avenue, Danielson; and 1491 West Main Street, Willimantic (the "LOI Sites").

Subsequent to these submissions, the General Assembly revised the CON procedures, requiring only notice to the Department of service terminations.

On November 9, 2010, Stonington provided written notice to OHCA of the termination of service at the LOI Sites. A copy of the November 9, 2010 letter is enclosed. The November letter did not, due to a clerical oversight, include reference to the termination of service at 86 BPR.

On Friday, November 12, 2010, Stonington received a telephone acknowledgement of its notification from Mr. Steve Lazurus at OHCA, indicating no further information was necessary.

Accordingly, Stonington writes to provide OHCA written notice of the 86 BPR termination of service as follows:

Service Address: 86 Boston Post Road, Waterford, CT

Service/License: Facility for the Care or Treatment of Substance Abusive or Dependent Persons
(License No. 0317)


Mental Health Day Treatment (License No. 0000-0045)

Patient Impact: Clients receiving services at the Service Address were transitioned to the Stonington Clinic located at 428 Long Hill Road, Groton or 1353 Gold Star Highway, Groton. Stonington provides transportation to/from program daily so no lack of access/service resulted from this termination.

Services at 86 BPR were discontinued effective June 7, 2010, and the original licenses are being returned to DPH simultaneously herewith.

The information with respect to these termination notifications is as follows:


