Project Description: Yale-New Haven Hospital ("Hospital") requests a modification of the Certificate of Need ("CON") authorization issued under Docket Number 08-31082-CON, in order to extend the CON expiration date from July 15, 2009 to July 15, 2010. The CON authorization was for the acquisition and operation of an angiography suite with digital flat detector, replacing an existing single-plane angiography suite, pursuant to Section 19a-639c of the Connecticut General Statutes.

Findings of Fact

- 1. On July 14, 2008, under Docket Number 08-31082-CON, the Office of Health Care Access ("OHCA") granted a Certificate of Need ("CON") pursuant to Section 19a-639c of the Connecticut General Statutes, to Yale-New Haven Hospital ("Hospital") to acquire and operate an angiography suite with digital flat detector, replacing an existing single-plane angiography suite.
- 2. Condition #1 of the CON authorization is as follows:
 - "1. This authorization shall expire on July 15, 2009. Should the Hospital's replacement project not be completed by that date, the Hospital must seek further approval from OHCA to complete the project beyond that date."
- 3. On July 14, 2009, OHCA received the Hospital's request for a one-year extension of the CON expiration date set forth in Condition #1, to July 15, 2010. This modification request is being reviewed by OHCA under Docket Number 09-31082-MDF.
- 4. The Hospital indicates the following related to this modification request:
 - a. The project authorized by OHCA under Docket Number 08-31082-CON represents phase II of a two-phase project.
 - Phase I involved the replacement of a single plane angiography system authorized by OHCA under Docket Number 08-31080-WVR and the replacement of a bi-plane neuro angiography system authorized by OHCA under Docket Number 08-31081-WVR; and
 - ii. On January 9, 2009, OHCA modified both of the phase I replacement projects in order to extend the CON expiration dates from January 17, 2009 to January 17, 2010.
 - b. The Hospital states that given the revised timeline due to delays involving completion of the phase I projects and the domino effect of phase II needing to follow phase I, a modification to extend the time for phase II is being requested. The Hospital needs until July 15, 2010 to complete this last phase.
- 5. The Hospital listed the following as accomplishments-to-date:
 - a. The completion of the bi-plane neuro-angiographic project as authorized under Docket Number 08-31081-WVR; and
 - b. The demolition work has begun for the second single-plane angiographic suite authorized under Docket Number 08-31080-WVR.

Discussion

OHCA has reviewed this request for a modification to a previously authorized CON and finds that the relationship of the CON authorized under Docket Number 08-31082-CON, to Section 19a-637, C.G.S., is not significantly altered by this request for a modification under Docket Number 09-31082-MDF. The modification proposal does not alter the intended scope or the authorized capital expenditure. The delays related to this project appear to have been unforeseen and are directly related to delays experience in the implementation of two separate but related CON authorized projects. The request for an extension of the CON expiration date until July 15, 2010 appears to be reasonable.

Order

Based on the above discussion and the reasons provided in the Hospital's modification request, OHCA hereby grants the request and modifies the CON authorized under Docket Number 08-31082-CON. Condition #1 of the CON authorization under Docket Number 08-31082-CON is modified as follows:

1. This authorization shall expire on July 15, 2010. Should the Hospital's replacement project not be completed by that date, the Hospital must seek further approval from OHCA to complete the project beyond that date.

All other conditions set forth in the CON authorization issued under Docket Number 08-31082-CON not modified herein, will remain in full effect.
