Project Description: Community Mental Health Affiliates, Inc. ("CMHA or "Applicant") is proposing to terminate mental health and substance abuse services in Hamden, Connecticut, with an associated capital expenditure of \$2,000.

Nature of Proceedings: On February 18, 2010, the Office of Health Care Access ("OHCA") received the proposal of Community Mental Health Affiliates, Inc. ("CMHA or "Applicant") to terminate mental health and substance abuse services in Hamden, Connecticut, with an associated capital expenditure of \$2,000. The Applicant is a health care facility or institution as defined by Section 19a-630 of the Connecticut General Statutes ("C.G.S.").

A notice to the public concerning OHCA's receipt of the Applicant's Letter of Intent was published in *The New Haven Register* on August 2, 2009. Pursuant to Section 19a-638, C.G.S., three individuals or an individual representing an entity with five or more people

had until March 11, 2010, the twenty-first calendar day following the filing of the Applicant's CON application, to request that OHCA hold a public hearing on the Applicant's proposal. OHCA received no hearing requests from the public.

OHCA's authority to review and approve, modify or deny the CON application is established by Section 19a-638, C.G.S. The provisions of this section as well as the principles and guidelines set forth in Section 19a-637, C.G.S., were fully considered by OHCA in its review.

Findings of Fact

Clear Public Need

Impact of the Proposal on the Applicant's Current Utilization Statistics Proposal's Contribution to the Quality of Health Care Delivery in the Region Proposal's Contribution to the Accessibility of Health Care Delivery in the Region

- 1. It is found that Community Mental Health Affiliates, Inc. ("CMHA" or "Applicant") is a is a non-profit provider of mental health and substance abuse treatment services, headquartered in New Britain, CT. (July 21, 2009, Letter of Intent, pages 1 and 7)
- 2. The Applicant merged with and assumed operations of Family Services of Central Connecticut ("FSCC") in 2007. The Applicant contends that FSCC has been providing services in Hamden since 2002. (September 28, Initial CON Application, page 3)
- 3. Docket No.:06 30899-EXM, the merger between Family Services of Central Connecticut, Inc. with and into CMHA, meets the exemption requirements of Section 19a-639b of the Connecticut General Statutes and, therefore, was exempt from OHCA's CON process.
- 4. The Applicant provides outpatient mental health services and intensive outpatient services to adults with substance abuse disorders at 1890 Dixwell Avenue, in Hamden. CMHA is licensed by DPH as a Psychiatric Outpatient clinic for adults and as a Facility for the Care and Treatment of substance Abusive or Dependent Persons. (July 7, 2009, Letter of Intent, page 7)
- 5. According to the State of Connecticut Department of Public Health ("DPH"), CMHA's Hamden facility was closed effective October 1, 2009. (November 10, 2009, memo from Facility Licensing & Investigations Section, Department of Public Health)
- 6. The Applicant provided minutes from the June 2009, Board of Directors meeting showing that the Board voted to approved their budget for 2009-2010, on which the services at Hamden were excluded. (September 28, Initial CON Application, page 3)
- 7. The Applicant operates seven outpatient programs in Connecticut that provide the same outpatient mental health services and intensive outpatient services to adults with substance abuse disorders provided at CMHA in Hamden. The outpatient programs' services, current hours of operation and current capacity are as follows:

- 8. The Applicant asserts that they have provided referrals for clients who were in the CMHA's program in Hamden. Clients were notified in person at their sessions and/or via a letter informing them of the closing and offering them referral options. The Applicant provided copies of the letters as evidence. (September 28, Initial CON Application, pages 4-5)
- 9. The Applicant contends that phone calls were made to area providers and their affirmative responses led the Applicant to include them on their letter to clients as referral options. (September 28, Initial CON Application, page 4)

10. The Applicant assert that the following table illustrates that between FY 2008-2009, the majority of patients who received services at CMHA's Hamden location were from the two adjacent towns of Hamden and New Haven, 22.9% and 22.5%, respectively.

11. The Applicant contends that on an ongoing basis, access to services for the residents of Hamden and New Haven has occurred and will continue through their Local Mental Health Authority, the 211 Information number for other existing services, DMHAS, or through the mental health and abuse service and provider networks in that area. The following table lists the providers of similar services in the Greater New Haven area:

- 12. The Applicant did not provide the existing providers' capacity as requested by OHCA. The Applicant contends that due to program closure, program staff were unable to make follow up phone calls to providers to determine capacity. (December 9, 2009, Completeness Response, page 55)
- 13. OHCA finds that the Applicant demonstrated the availability of services similar to those previously offered by CMHA in Hamden are offered by other providers in the Greater New Haven area.

14. The Applicant provided historical and actual volume for the Hamden location indicating a decrease in volume for IOP in FY 2007 and increases thereafter. The Applicant contends that prior to FY 2008-2009 CMHA did not offer aftercare services, and once the services were added, the volume at their Hamden location experienced an increase.

- 15. The project has an associated capital expenditure of \$2,000. (September 28, Initial CON Application, pages 2 and 8)
- 16. The Applicant contends that in spite of the increased in volumes, in FY 2009, the program operated at a deficit of \$60,042 and was projected to increase by 3% each year through 2010. (September 28, Initial CON Application, page 6 and December 9, 2009, Completeness Response, page 56)
- 17. The Applicant contends that CMHA sought but was denied SAGA provider status in Hamden, eliminating SAGA as a revenue source. The DSS Families in Crisis Grant, the sole grant supporting the Hamden site, was eliminated from the state budget for 2010. (December 9, 2009, Completeness Response, pages 52-53)

- 18. With the operation of the Hamden location, the Applicant realized a loss from operations of \$61,843 in FY 2010, \$63,699 in FY 2011 and \$65,610 in FY 2012. (September 28, Initial CON Application, page 47)
- 19. The Applicant's payer mix for the Hamden location indicates that Medicare and Tricare patients were not served during FY 2008-2009. All patients served through governmental payers at FSCC were enrolled in Medicaid.

- 20. The Applicant contends that efforts to improve productivity have been demonstrated throughout the proposal. (September 28, Initial CON Application, page 10)
- 21. The Applicant contends that there are no characteristics of the Applicant's patient/physician mix that make the proposal unique. (September 28, Initial CON Application, page 10)
- 22. The Applicant provided resumes of its executive and clinical leadership demonstrating that the agency possesses sufficient technical, financial and managerial competence and expertise to provide efficient and adequate service to the public. (September 28, Initial CON Application, page 6)

Rationale

The Office of Health Care Access ("OHCA") approaches community and regional need for Certificate of Need ("CON") proposals on a case by case basis. CON applications do not lend themselves to general applicability due to a variety of factors, which may affect any given proposal; e.g. the characteristics of the population to be served, the nature of the existing services, the specific types of services proposed to be offered, the current utilization of services and the financial feasibility of the proposal.

Community Mental Health Affiliates, Inc. ("CMHA" or "Applicant") is a non-profit corporation headquartered in New Britain that provides mental health and substance abuse treatment services throughout Connecticut. CMHA has a site at 1890 Dixwell Avenue in Hamden. The Hamden site provided outpatient mental health services and intensive outpatient services to adults with substance abuse disorders. The Applicant operates seven outpatient programs in Connecticut that provide the same outpatient mental health services and intensive outpatient services to adults with substance abuse disorders provided at CMHA in Hamden.

The Applicant provided utilization data by town for FY 2008-2009 demonstrating that the majority of its Hamden location clients resided in either in New Haven (22.5) or Hamden (22.9%), respectively. The Applicant asserted that they have provided referrals for former CMHA Hamden clients to area providers and that access to services for the residents of both Hamden and New Haven will be maintained through their Local Mental Health Authority, the 211 Information number for other existing services, DMHAS, or through the mental health and abuse service and provider networks in that area.

Although according to the Connecticut Department of Public Health ("DPH"), the Applicant turned in its license on October 1, 2009, access to similar services provided by the Applicant at the Hamden location will continue to be provided through other area providers or state sponsored programs (Finding #13). Therefore, OHCA concludes that termination of services at the Hamden location did not impact access, as similar services are maintained.

Order

The proposal of Community Mental Health Affiliates, Inc. to terminate outpatient services for children and adults in Hamden, Connecticut with an associated capital expenditure of \$2,000 is hereby GRANTED.

All of the foregoing constitutes the final order of the Office of Health Care Access in this matter.
