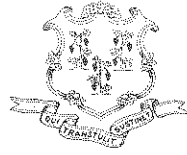

On January 31, 2013, the Office of Health Care Access ("OHCA") denied the Certificate of Need ("CON") application of Greenwich Hospital and Yale New Haven Hospital ("Applicants") under Docket Number 12-31748-CON to establish and operate an elective angioplasty program at Greenwich Hospital pursuant to Conn. Gen. Stat. § 19a-639. On February 15, 2013, the Applicants filed a Petition requesting that OHCA reconsider the above decision.
