Dear Dr. Kaye:

On February 8, 2010, the Office of Health Care Access ("OHCA") received a CON Determination Form 2020 regarding Advanced Radiology Consultants, LLC ("Applicant") acquisition and operation of a GE Ovation Magnetic Resonance Imaging ("MRI") scanner in 2003. OHCA has reviewed your request and makes the following findings:

1. Advanced Radiology Consultants, LLC ("Applicant") is a for-profit entity that provides a fully array of diagnostic services in Connecticut.
2. The Applicant currently operates the MRI scanner at its Trumbull location.
3. OHCA finds that, in 2005, under Docket #05-30480-DTR OHCA determined that the Applicant purchased the MRI Scanner in 2003 for \$350,000, which included delivery, installation and warranty.
4. OHCA further found in Docket #05-30480-DTR, that the MRI Scanner has been in operation since 2003.

Based on these findings, OHCA has determined that Certificate of Need approval is not required for the acquisition and operation of the MRI scanner because it was purchased prior to the implementation of Public Act 05-93 and the equipment was in operation prior to July 1, 2006.
