

Prospect Medical Holdings, Inc. or an affiliate of PMH ("PMH") acquired substantially all of the assets of Greater Waterbury Health Network, Inc. ("GWHN") and its affiliates including Alliance Medical Group, Inc. ("AMG") (the "Transaction"). AMG was an affiliate of GWHN and, as part of the Transaction, PMH formed Prospect CT Medical Foundation, Inc., a Connecticut medical foundation ("PCMF"). As such, AMG transferred its assets, including employment agreements with physicians, to PCMF.
