1	Call to order and motion to open meeting	Steven Lazarus

Physician Practice Workgroup Meeting Minutes

May 12, 2022

The group had two members that planned to present at this meeting. The members were Robert Russo and Alan Coker.

Robert Russo, a representative for specialty practices, prepared a slide presentation entitled *Recruitment and Retention of Physicians in Connecticut and the Disappearing Independent Practice of Medicine.*

Below are some of the items discussed in the presentation.

- Physician Recruitment and Retention: Connecticut Landscape which was about the inability to retain physicians trained in CT.
- Barriers to Physician Recruitment and Retention such as an aging medical population, lack of loan forgiveness, administrative burdens, and a hostile medical liability climate.
- The Disappearing Independent Practice due to administrative burdens such as prior authorizations and difficulty in negotiating with insurers.
- Physician Employment Landscape which shows an increase in hospital owned physicians over the last three years.
- Physician Recruitment and Retention Solutions such as loan forgiveness and changing the medical liability landscape.
- Preserving the Independent Practice of Medicine by fixing prior authorization issues and changing the ways physicians and insurers negotiate.

Alan Coker, a representative for consumers, gave a speech to the group on his life experiences with dealing with physicians. Some of his comments are provided below.

- He remembers when his physician came to his home to provide care.
- He indicated that it's difficult to find a physician these days as there are urgent care centers and walk in medical centers at local pharmacies such as CVS and Walgreens.
- He likes having an independent physician so he can shop around for a specialist if he needs one.
- He said patients and physicians are getting lost in the paperwork shuffling.
- He feels there are issues with treating Medicare and Medicaid patients and that they are treated differently than other patients.
- He believes some (not all) physicians just worry about the bottom line.
- He indicated that he's proud to be working with this workgroup as it gives him hope that issues facing society may in some way be corrected.

3 Next steps for the workgroup

Steven Lazarus

Steven indicated that he and Ron Ciesones are taking notes of the topics discussed today and working with members to do presentations over the next few months. He indicated that for June, he wants hospital members of the group and insurance company representatives to provide their viewpoints. Time will also be provided again for any physician members to speak. We'll be reaching out to consumers, hospitals, and insurance companies over the next month to get their perspectives on the workgroup's topics.

There were some comments by members on if there was any data on the cost of care or price transparency. There was also discussion regarding if there was an overview of services and providers in CT and where those services and providers are located.

As presentations and discussions wind down in the summer months, the hope is for group members to be broken into smaller groups so members can discuss the data that's been presented and to begin drafting suggestions on how to better improve oversight and regulation of physician groups in Connecticut.
