March 10, 2022

Steven Lazarus introduced Rachel Davis, Assistant Attorney General who provided the group with a presentation on how the Office of Attorney General (OAG) reviews Material Change of Ownership transactions.

Below are some of the items discussed in the presentation.

- Links to the Office of Health Strategy (OHS) Notification and Filings Portal along with the location of the Notifications and Filings on the OAG website.
- Statute Section 19a-486i related to certain mergers, acquisitions and other transactions.
- Statute Section 35-42 related to the antitrust act and investigations.
- A description of the different types of review the OAG office does when receiving a Notice of Material Change (Initial Review, Substantive Review, and Antitrust Investigation);
- A review of the Notice of Material Change forms which show the following:
 - a.) The date of notice showing the party submitting, effective date of the transaction, and a description of the transaction;
 - b.) The names of the parties to a transaction and their contact information;
 - c.) Information on the group practice subject to the proposed transaction and who will practice medicine with the resulting organization including the name of each physician, group practice(s) in which physician practices and specialties of each physician;
 - d.) Data on business entities that will be providing services following the effective date including the business names, address of each service location, description of services provided at each location, and the primary service area served by each.
- Contact information to reach someone at the OAG's office.
