- Ms. Burnham reviewed the purpose of today's meeting, see presentation here. She said there will be a review of how the Public Scorecard will look.
- Ms. Burnham provided a recap of the Quality Council's presentation regarding the Public Scorecard at the last Healthcare Innovation Steering Committee (HISC) meeting.

5. Public Scorecard Rob Aseltine

- Dr. Rob Aseltine, of UConn Health presented on the Public Scorecard. The Council reviewed the status update, website preview, and result preview.
- The Council discussed the organization reports that were sent to the advanced networks (AN). There was a question about whether we have heard back from all of the advanced networks. It was mentioned that we have not heard back from all of them but have heard from a subset. Meetings are being scheduled to talk, emails are being monitored to see if they have been opened, and the team will continue to reach out to them.
- There was a question about whether it will be listed on the website, the criteria to be an
 advanced health network or an organization so that smaller practices will understand why
 they are not up there. It was mentioned that there is a definition of an advanced network
 and it will be listed on the definition page and technical documentation. It was suggested
 that the definition be made clear on the website so that a practice will not question why
 they are not listed.
- There was a discussion about two populations of physicians, those employed by a specific organization such as a medical school and those who are not. There was a question about whether this is being differentiated. It was mentioned that they are usually under two different organizations. It was mentioned that sometimes there are groups that elect an intern into a contract. It was noted that in terms of view sometimes they had to disaggregate certain systems that sometimes contract together. They were separated for public use and a better view.
- There was a discussion about CAHPS. There was a question about how the CAHPS survey data being captured. It was mentioned that the data is being collected two ways as part of the SIM evaluation. The partners at Yale are doing a commercial survey and contracting with DSS to do a third round of the annual surveys. Also, Medicaid received additional funding to do the CAHPS survey they do with their population and utilize a vendor. The survey results are reported to Yale and then given to us to use in the public scorecard.
- The Council discussed the organizational ratings. It was mentioned that it is nice to see variability in stars, variability drives improvement. There was a question on whether the council ever made a decision on the distinction between the core and reporting measures. It was mentioned that the council deliberated on this and the consensus was that it could be very confusing for the public and there would be other ways of communicating it to the organizations that are being rated. It was mentioned that none of the measures are more important than the others but if the QC would like to have a deep dive, they could have a little narrative. It was suggested that an asterisk could be added if needed.
- There was a question about whether there will be a frequently asked questions section or anything about the data and the limitations. It was mentioned that there will be a section at
