### Social Equity Council - Workforce Development Plan Criteria

The Social Equity Council, supported by the Office of Workforce Strategy and the Governor's Workforce Council, is responsible for ensuring applicants' workforce development plans are both (i) focused on reinvesting or providing employment and training opportunities for individuals in disproportionately impacted areas and (ii) well organized to provide said opportunities. The below Workforce Development Plan Criteria are an important element of the overall licensing application for new Cannabis establishments in Connecticut. The Office of Workforce Strategy and the Workforce Development Committee of the Social Equity Council request that the components of the Workforce Development Plan Criteria are considered with fidelity as part of the larger licensing application. Applicants will be expected to meet all criteria to qualify for a license. Applicants will be expected to earn 80/100 points from the below criteria in order to qualify for a license.
